#### COURSE FORMAT

Three instructional hours per week for a 15-week semester, which includes two weeks for final exams.

### **CALENDAR DESCRIPTION**

As the final course in the musicianship and aural skills sequence, this class deepens students' aural and analytical engagement with chromaticism, formal structures, and complex rhythmic practices. Students will explore chromatic melodic and harmonic features—including modal mixture, Neapolitan and augmented sixth chords, and distant modulations—through performance, transcription, and analysis. The course emphasizes rhythm and meter in both historical and contemporary contexts, including super-divided beats, asymmetric meters, and syncopation in jazz, ragtime, blues, and popular music. Students will also study phrase structure and form in repertoire ranging from the 16th to 20th centuries. Through integrated aural work, rhythm training, and ensemble performance, students will apply advanced musicianship skills across diverse musical traditions.

### **COURSE STUDENT LEARNING OUTCOMES**

# On successful completion of this course, students will be able to do the following:

- Apply aural and analytical skills to identify and perform chromatic melodic features and harmonic progressions—including tonicizations, modal mixture, modulations, as well as chromatic sequences in tonal music.
- Aurally identify and describe formal structures from various world musics.
- Apply aural and analytical skills to identify and communicate complex rhythmic patterns within different meters - such as simple, compound and mixed meter across single and multi-part textures - through singing, rhythmic execution, and notation.
- Transcribe tonal excerpts that include advanced harmonic progressions including augmented 6th chords and extended chromatic sequences that involve applied chords, from various world musics.
- Work collaboratively in ensembles, incorporating musicianship skills learned in the class.
