COURSE FORMAT

CALENDAR DESCRIPTION

This course acknowledges the acting skills which are learned during rehearsals and practical work on theatre productions. Musical Theatre students will take part in a fully realized stage production.

COURSE STUDENT LEARNING OUTCOMES

On successful completion of this course, students will be able to do the following:

- Integrate and demonstrate self-assessment tools within a rehearsal process
- Interpret the text for psychological, behavioural and socio-economic information to build a character;
- Explore the intensive, practical experience of performance in a full-scale production.

COURSE CONTENT

This course will consist of weekly rehearsals of a fully realized show, where students learn interpretation, blocking, character analysis, and performance on a larger scale. With prior approval of the Theatre department, a different production may be substituted instead of this show. This may take place within the University or at an outside theatre.

EVALUATION PROFILE

Evaluation will be based on the practice and performance of fully staged show. To achieve credit, students must successfully complete the assigned Actor’s book work, display professional conduct, and show a heightened awareness of craft by the end of the course.

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

Prohibited Conduct: The following are examples of other conduct specifically prohibited:
