Capilano University is named after Chief Joe Capilano (1854–1910), an important leader of the Skwxwú7mesh (Squamish) Nation of the Coast Salish Peoples. We respectfully acknowledge that our campuses are located on the unceded territories of the səlilwəta+ (Tsleil-Waututh), shíshálh (Sechelt), Skwxwú7mesh (Squamish), and xwməθkwəyəm (Musqueam) Nations.

COURSE FORMAT

Three hours of class time, plus an additional hour delivered through on-line or other activities for a 15-week semester, which includes two weeks for final exams. This course may also be offered in mixed mode or in online format and/or condensed format.

CALENDAR DESCRIPTION

This course aims to engage the student with a number of global dilemmas and issues. The relationship between individuals, society and the natural world is examined. It incorporates the central concepts of sustainability in our day-to-day lives. Students will gain a deeper appreciation for their interconnectedness to the Earth both as consumer and citizen.

COURSE STUDENT LEARNING OUTCOMES

On successful completion of this course, students will be able to do the following:

- 1. Define and explain the principles of sustainability (environmental, economic and social) and their interconnections.
- 2. Explore how the principles and ethics of environmental stewardship can inform your individual choices.

- 3. Describe the impact of human activities on the environment and climate.
- 4. Examine Indigenous ways of knowing and relating to the natural world with a focus on engaging personally and intellectually with our own relationships to the waters and land, to ourselves, and to each other.

5. Analyze sustainable practices that promote environmental conservation and restoration.

Students who complete this Self and Society course will be able to do the following:

- 1. Identify potential root causes of local/global problems and how they affect local/global cultures, economies, politics, and policies
- 2. Assess and evaluate individual and collective responsibilities within a diverse and interconnected global society
- 3. Apply concepts of sustainable development to address sustainability challenges in a global context
- 4. Synthesize a range of differing community perspectives on ethics and justice and explain how these perspectives can inform structural change

COURSE CONTENT

Topics and discussions for REC 152 include:

- Understanding sustainability and its interconnections
- Environmental ethics
- Human impacts on the environment and climate (e.g., climate change, biodiversity loss, waste and pollution, resource extraction, consumerism, ecological footprints, planetary boundaries, food waste, etc.)
- Indigenous ways of knowing and relating to the natural world
- Sustainable practices and frameworks (e.g. Sustainable Development Goals, protected areas and Indigenous protected and conserved areas, strong sustainability, Inner Development Goals, codes of conduct, The Natural Step, sustainable cities, etc.)
- Exploring our personal choices and relationships with the waters, land, ourselves and each other

Academic dishonesty is any act that breaches one or more of the principles of academic integrity. Acts of academic dishonesty may include but are not limited to the following types:

Cheating: Using or providing unauthorized aids, assistance or materials while preparing or completing assessments, or when completing practical work (in clinical, practicum, or lab settings), including but not limited to the following:

- Copying or attempting to copy the work of another during an assessment;
- Communicating work to another student during an examination;
- Using unauthorized aids, notes, or electronic devices or means during an examination;
- Unauthorized possession of an assessment or answer key; and/or,
- Submitting of a substantially similar assessment by two or more students, except in the case where such submission is specifically authorized by the instructor.

Fraud: Creation or use of falsified documents.

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

Prohibited Conduct: The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting
 and removing such work from a photocopier or printer, or collecting the graded work of
 another student from a stack of papers);
- Falsifying one's own and/or other students' attendance in a course;
- Impersonating or allowing the impersonation of an individual;
- Modifying a graded assessment then submitting it for re-grading; or,
- Assisting or attempting to assist another person to commit any breach of academic integrity.
