Capilano University is named after Chief Joe Capilano (1854–1910), an important leader of the Skwxwú7mesh (Squamish) Nation of the Coast Salish Peoples. We respectfully acknowledge that our campuses are located on the unceded territories of the səlilwəta+ (Tsleil-Waututh), shíshálh (Sechelt), Skwxwú7mesh (Squamish), and xwməθkwəyəm (Musqueam) Nations.

COURSE FORMAT

Three hours of class time, plus an additional hour delivered through on-line or other activities for a 15-week semester. This course may also be offered in mixed mode or online.

COURSE PREREQUISITES

9 credits of 100-level or higher coursework and TOUR 111 or TOUR 160 or REC 110 or REC 111

CALENDAR DESCRIPTION

This course will provide career counselling, such as job search coaching, feedback, tips, tools and techniques for outdoor recreation educational and career development through one-on-one meetings, class workshops, industry forums, and networking opportunities. Course work will focus on defining and developing skills necessary for the job search process. The course will provide tools and strategies to prepare students to research, apply for, and secure an appropriate placement in the outdoor recreation industry. Confidence in interview skills and presentation skills will be strengthened through workshop activities. Students will develop a personal career plan to help in identifying workplace opportunities consistent with defined career and educational goals.

COURSE NOTE

REC 191 is equivalent to TOUR 133. Duplicate credit will not be granted for this course and TOUR 133.

- 3. Apply strategies for effective interviews and negotiation of employment contracts
- 4. Identify skills, aptitudes and qualifications for jobs in the outdoor recreation industry.
- 5. Acquire appropriate tools to prepare for long-term career success including, for example, personal and professional self-assessment, professional skill development, lifelong learning, career goals, networking, business etiquette, success factors, etc.

- Cooperative education model
- Career opportunities in outdoor recreation: Qualifications, Competencies and Skills
- Personal and professional self-assessment, e.g. Personal branding, learning styles, personality models, and behavioural preferences
- Job search strategies
- Digital presence
- Interview skills
- Interacting with industry
- Foundation of workplace safety: e.g., work permits, insurance, employment contracts, risk management and other considerations
- Strategies for workplace success
- Summer work term overview
- Individual support

Violations of academic integrity, including dishonesty in assignments, examinations, or other academic performances, are prohibited and will be handled in accordance with the Student Academic Integrity Procedures.

Academic dishonesty is any act that breaches one or more of the principles of academic integrity. Acts of academic dishonesty may include but are not limited to the following types:

Cheating: Using or providing unauthorized aids, assistance or materials while preparing or completing assessments, or when completing practical work (in clinical, practicum, or lab settings), including but not limited to the following:

- Copying or attempting to copy the work of another during an assessment;
- Communicating work to another student during an examination;
- Using unauthorized aids, notes, or electronic devices or means during an examination;
- Unauthorized possession of an assessment or answer key; and/or,
- Submitting of a substantially similar assessment by two or more students, except in the case where such submission is specifically authorized by the instructor.

Fraud: Creation or use of falsified documents.

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

Prohibited Conduct: The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting and removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);
- Falsifying one's own and/or other students' attendance in a course;
- Impersonating or allowing the impersonation of an individual;
- Modifying a graded assessment then submitting it for re-grading; or,
- Assisting or attempting to assist another person to commit any breach of academic integrity.

Sexual Violence and Misconduct
