We respectfully acknowledge that our campuses are located on the unceded territories of the səliłwətał (Tsleil-Waututh), shíshálh (Sechelt), Sk̓wx̓wú7mesh (Squamish), and xʷməθkʷəy̓əm (Musqueam) Nations.

COURSE FORMAT

Three hours of class time, plus an additional hour delivered through on-line or other activities for a 15-week semester, which includes two weeks for final exams.

COURSE PREREQUISITES

45 credits of 100-level or higher coursework

CALENDAR DESCRIPTION

Death is a universal experience, but the ways we die, and what happens afterwards, is profoundly shaped by one's society. This course explores death and dying as a social process, focusing on institutions such as hospitals, hospices, and funerals. It will explore topics like Medical Assistance in Dying, mourning, and the toxic drug crisis, and reflect on the place of death in our own lives. We will consider the diverse ways people understand mortality, including how we are socialized into death as we are into life.

COURSE NOTE

SOC 365 is an approved Self and Society course for Cap Core requirements.

COURSE STUDENT LEARNING OUTCOMES

On successful completion of this course, students will be able to do the following:

- Consider the place of death in our personal lives in connection with larger social processes and cultural frameworks.

- Evaluate the roles of hospice, palliative care, and end-of-life services in supporting dying individuals and their communities.
- Reflect on the decisions of Indigenous communities regarding the memorialization of unmarked burial sites associated with the Indian Residential Schools.
- Describe how death is structured through legal frameworks and ethical codes.
- Analyze representations of death in popular culture and media.

Students who complete this Self and Society course will be able to do the following:

- Analyze the impact of colonialism and racism on Indigenous peoples.
- Synthesize a range of differing community perspectives on ethics and justice and explain how these perspectives can inform structural change.
- Generate strategies for reconciling Indigenous and Canadian relations.
- Explain how contexts (e.g. cultural, historical, colonial, economic, technological) shape identity formation and social structures.

Fraud: Creation or use of falsified documents.

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

Prohibited Conduct: The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting and removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);
