## COURSE FORMAT

Three hours of class time, plus an additional hour delivered through on-line or other activities for a 15-week semester, which includes two weeks for final exams.

## COURSE PREREQUISITES

45 credits of 100-level or higher coursework

## CALENDAR DESCRIPTION

This course explores contemporary issues in queer studies from an interdisciplinary perspective. Drawing from a range of academic and community-based knowledge, the course will engage theory, history, and various analytic methods to explore queer histories, theories, cultures and debates, including Indigenous Two-Spirit identities.

## COURSE NOTE

WGST 100 and/or WGST 111 are recommended. WGST 401 is an approved Self and Society course for Cap Core requirements.

## REQUIRED TEXTS AND/OR RESOURCES

All readings and course resources identified by the instructor. Students are encouraged to use the queer streaming video collections and research resources at the CapU library.

## COURSE STUDENT LEARNING OUTCOMES

**On successful completion of this course, students will be able to do the following:**

- Apply a critical, decolonial and/or intersectional lens to historical and contemporary issues in queer theory and culture
- Demonstrate understanding of important movements and moments in queer history
- Analyse queer discourses and representations

- Identify and deconstruct evidence within queer cultural debates
- Critically explore personal perspectives in relation to course content

**Students who complete this Self and Society course will be able to do the following:**

- Assess and evaluate individual and collective responsibilities within a diverse and interconnected global society.
- Analyze the impact of colonialism and racism on Indigenous peoples.
- Synthesize a range of differing community perspectives on ethics and justice and explain how these perspectives can inform structural change.
- Explain how contexts (e.g. cultural, historical, colonial, economic, technological) shape identity formation and social structures.

**COURSE CONTENT**

Weeks 1 – 4: Introductory theories and histories: what’s at stake for queer futures?; prominent queer histories (Stonewall, AIDS and The Fruit Machine); essential tools for queer analysis (intersectionality and critical race theory)

Weeks 5-7: Two spirit histories, identities and colonialism; pride, police and homonationalism; de/anti-colonial queer futures

Weeks 8-12: Contemporary issues and debates: activism & ethics in queer research practices; queer media & representation; trans+ identities: visibility, health care, and celebration; queer crip: disability theories and materialities; education: access, policy, privacy, and politics

Weeks 13: Term synthesis, presentations and in-depth analysis of term tensions

Weeks 14-15: Final Exam Period

- Submitting of a substantially similar assessment by two or more students, except in the case where such submission is specifically authorized by the instructor.

**Fraud:** Creation or use of falsified documents.

**Misuse or misrepresentation of sources:** Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

**Plagiarism:** Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism:** Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

**Prohibited Conduct:** The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting and removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);
- Falsifying one's own and/or other students' attendance in a course;
- Impersonating or allowing the impersonation of an individual;

- Modifying a graded assessment then submitting it for re-grading; or,
- Assisting or attempting to assist another person to commit any breach of academic integrity.
